TADA - Officers Meeting - May 20, 2009

Stewart brought the meeting to order at 7:30 and asked Cheryl for the report on the budget. Cheryl advised the board that Rays Steel City Saloon and Shake and Bake still owe their dues. The overall account has about \$2200, which gives the TADA enough funds for more Tshirts and bumper stickers. The shirts are only sold for \$3.00 - \$4.00 over our cost. But there is about \$460.00 for the end of the year party. Andrew asked what we paid for last year trophies last year and Cheryl advised the board \$1017 and the Rays was paid \$526.00. Cheryl advised that cost of the keg has gone up to over \$100-and we have about \$50 - \$60 less. Kelli advised the board that someone has to go speak with him, Joelle advised the board that she has placed calls and have not received a call back. We have to advise him that we need more food. Kelli advised the board that Ray last year at the end of the party that he was willing to "WOW" us the next year. Andrew feels that the facilities were nice, but the food ran out too fast, the keg ran out too fast and the prices of the beers were too expensive. The positive aspects of having at Rays there is not as much work in set up and clean up as it is at the ELKS lodge. Sheila mentioned that the cost of retaining a bartender at the Elks was increased from \$75 to \$100.

Don and Joelle will be meeting at Rays on Thursday at 10:00 am. The party will be held on Saturday May 30<sup>th</sup>. The time is: 1:00 PM – trophy presentation is at 2:00 PM and seated tournament begins at 4:00 PM Stewart asked Don if he could set up the boards at the location of the party, Don agreed. It was mentioned that there are 5 boards needed and lights.

Andrew sent all the officers the listing of all the trophies. Doug was asked what the update on the trophies. He advised the board that he spoke to Tim Yoho, but also advised that we are on a deadline and he will be giving Tim Yoho the list of trophy winners by Thursday May 21<sup>st</sup>, and the trophies will be in Doug's hand by 28<sup>th</sup> of May. Doug then mentioned about the individuals who were ranked and did

not have any competition within their division and did not get a trophy. Doug mentioned that it happened to him personally and Joelle as well last season. Discussion was amongst the board if a new trophy plaque should be created, that if there is no competition B vs B etc... if they achieve High Trophy Points or High Bonus Points should it be written in the by laws that this should be changed or should they be able to get a trophy? According to Sheila – if you are in a division and there is no competition and there is no one in your ranking – that is the darters choice.

Cheryl asked that Jesse on her team be moved up to C+ because she has been playing for 2 years. Board agreed.
