AGENDA ITEM: CALL MEETING TO ORDER. TAKE ROLL CALL.

The regular meeting of the Tallahassee Area Dart Association Board of Directors meeting was called to order by Lyle Herrick, President. The Secretary was in attendance. Roll was taken.

AGENDA ITEM: REVIEW DIVISION 3 MEETING

Several issues were discussed – they included: the recruitment of more people into darts, changing the day from Saturday to a more convenient day during the week, offering a bulleye drawings and prizes to attract more players, advertising darts and darting events as local community events in such medium as the Tallahassee Democrat's Friday Limelight and on WCTV's Good Morning Show and Midday's "In the Spotlight" Features, offering dart clinic to teach people how to play darts and strategies they can use to improve their game.

It was suggested that a PR Committee might need to be formed to implement these ideas.

The system would work as follows: Chas will call the four Division Reps; they will in turn call their Division Captains; who will in turn call their teams.
